ARTICLES OF INCORPORATION

These Articles of Incorporation are signed and acknowledged by the incorporators for the purpose of forming a non-profit corporation under the provisions of Act No. 327 of the Public Acts of 1931, as amended, as follows:

ARTICLE I.

ARTICLE II.

The purpose or purposes for which the corporation is formed are as follows:

To organize a group of property owners at Douglas Lake, Munro Township, Cheboygan County, Michigan for the purpose of seeking ways and means to improve property and lake conditions for the utilization of all residents. Toward this end the association will seek to work with various public and private agencies to promote areas of sanitation, fishing, roads, and overall property improvement; all leading to the betterment of the general welfare of its residents.
